

DATA SUBJECT APPLICATION FORM FOR ANADOLU EFES BİRACILIK VE MALT SANAYİİ ANONİM ŞİRKETİ

1. General Principles for Application

According to article 11 of the Personal Data Protection Law (the “**Law**”), you can make the following requests in your capacity as the personal data subject (the “**Data Subject**”) by referring to Anadolu Efes Biracılık ve Malt Sanayii Anonim Şirketi (the “**Company**”):

- 1) Learning whether your personal data are processed or not,
- 2) Requesting information about the processing activity if your personal data have been processed,
- 3) Learning the purpose of processing of your personal data and whether these data are used suitably for this purpose,
- 4) Knowing any third parties in Turkey or abroad to whom your personal data are transferred,
- 5) Requesting the correction of your personal data if they are processed incompletely or incorrectly and asking the notification of such correction to the third parties to whom your personal data are transferred within this scope,
- 6) Requesting the deletion or destruction of your personal data and asking the notification of such deletion or destruction to the third parties to whom your personal data are transferred within this scope in the event that the reasons requiring the processing of your personal data disappear in terms of purpose, duration and legitimacy although they have been processed in compliance with the Law and other applicable legislations,
- 7) Raising an objection against any result to your disadvantage which is obtained by way of analysis of the processed data exclusively through automatic systems,
- 8) Requesting the indemnification of any loss if you incur a loss due to unlawful processing of your data.

Our company will finalize your request as soon as possible and within not later than thirty (30) days depending on the nature of the request pursuant to article 13 of the Law and our response will be delivered to you either in writing or through the electronic environment.

This Application Form is drawn up for the purpose of identifying your relationship with our Company upon your application and determining all your personal data processed by our Company, if applicable, and providing an accurate, complete and timely response for your application. Our Company reserves the right to ask for additional information and documents for the sake of identification and verification of authorization in order to prevent unauthorized and unlawful applications made in your name, prevent data transfers to third parties in an unlawful and unfair manner and particularly ensure the security of your personal data. In the event that the information related to your requests communicated through the Application Form is not accurate and updated or an unauthorized application is made, our Company shall not be held responsible for any requests resulting from such incorrect information or unauthorized application.

2. Application Method

You can submit your requests to our Company within the scope of your application right either in writing or through the registered electronic mail (KEP) address, safe electronic signature or mobile signature according to article 13 of the Law and article 5 of the Communiqué on Principles and Procedures for Application to Data Controller.

Written applications can be made in the form of personal application by the Applicant, through a notary office or delivery to the KEP address of our Company with a “safe electronic signature” as defined in the 5070 numbered Electronic Signature Law.

The following issues should be taken into consideration at the time of application for written applications to be made by the Data Subject:
